Post Adoption Services based upon child's need and family circumstances.</p>	<p>Provides permanency for a child by becoming a permanent and legal member of a family with all the legal rights of a birth child.</p> <p>Adoption is a lifelong legal relationship.</p>	<p>Parental rights of parents must be terminated unless it is a customary adoption established through Tribal court.</p>	<p>Upon entry of adoption decree, child becomes legal child of adoptive parents. The adoptive parents have all care, custody and legal rights to make decisions on the child's behalf. Child has inheritance rights.</p> <p>Title IVE adoption assistance can follow the youth to a subsequent adoption.</p>	<p>Adoptive parents assume full parental rights. Birth parents have no parental rights after termination, unless a customary adoption established through Tribal court.</p> <p>Birth and adoptive parent may have ongoing contact under an open communication agreement.</p>	<p>By applying for assistance through the adoption support program, adoptive parents may be eligible for finalization costs including legal fees. High school/high school equivalency program; or</li> <li>2. Post-secondary academic or vocational program; or</li> <li>3. Participating in a program to promote employment; or</li> <li>4. Employed 80 hours or more a month</li> <li>5. Has a documented medical condition that prevents participation in the first four categories (effective 6/2016).</li> </ol>

<p>Title 13 Guardianship Note: CA does not provide ongoing services or supervision. *Children in guardianships are not considered foster children.</p>	<p>Provides permanency for a child with an approved adult when returned home and adoption has been determined not to be in the child's best interest. Legal relationship ends on the child's 18<sup>th</sup> birthday.</p>	<p>Parental rights are not required to be terminated. Although the parent continues to be the legal parent the guardian has full care, custody, and control of the child. The dependency is dismissed.</p>	<p>The legal guardian maintains physical and legal custody with full responsibility for care, custody, and the right to make decisions regarding the child. The guardian can choose whether or not to provide an inheritance to a child; it is not a right for the child. RGAP subsidy can transfer to a successor legal guardian if one is named in the RGAP agreement and the legal guardian becomes incapacitated or dies.</p>	<p>The guardianship order may include visits. All visits are the responsibility of the guardian. The court may continue to order that the birth parent is still responsible for child support.</p>	<p>A subsidized Guardianship may be available to licensed relatives that meet the requirements of the Relative Guardianship Assistance Program. They must be foster care licensed for at least 6 months with the child in placement prior to establishing the guardianship. The RGAP agreement must be signed prior to establishing the guardianship. The program also reimburses legal fees paid up front by the guardian. Or Guardians may apply for financial support (TANF) through local Community Service Offices, however; their household income will be reviewed to determine eligibility.</p>	<p>Medical coverage for the child is provided as specified in the R-GAP agreement. Or Guardians may apply for medical for the child through local Community Service Offices or put the child on their own insurance. Youth age 19 and 20 who are receiving SFA are not eligible for medical assistance.</p>	<p>Youth eligibility for post high school grants and scholarships is program specific. Participating in a program to promote employment; or</li> <li>4. Employed 80 hours or more a month</li> <li>5. Legal relationship ends on the child's 18<sup>th</sup> birthday.</p>	<p>Parental rights remain intact. Although the parent continues to be the legal parent the guardian has full care, custody or control of the child. Any dependency action will be dismissed.</p>	<p>The third party custodian becomes legal guardian with full responsibility for care, custody and the right to make decisions regarding the child.</p>	<p>Birth parent remains the legal parent and is responsible for child support. Custody orders may include visits. Modification of custody orders may occur if a substantial change has occurred</p>	<p>May apply for financial support through other DSHS agencies. Eligibility for medical, financial and food voucher programs is dependent upon program requirements.
