CASAs are professionally-trained volunteers who advocate for abused and neglected children both in and out of court. CASAs are instrumental in ensuring the system designed to protect child victims works effectively. Their advocacy helps resolve the case in a timely manner and ensures the child's best interests are considered at every decision point during the case. CASAs bring the community perspective and standard into dependency proceedings, thus contributing to the court's desire to operate openly and fairly. Utilizing trained, culturally-competent, supervised volunteers, the CASA model leverages scarce public resources and provides high-quality advocacy for the needs of children and youth.

The Chelan Douglas CASA/GAL program, with the aid of community members, hands out handmade Christmas stockings filled with gifts to children and youth who are assigned to our program and overseen as a courtesy. All children who are in the foster home or group home receive a Christmas stocking. The program also has a fund that provides for extra curricular activities, back-to-school clothing and supplies, and bikes and helmets so that children and youth in foster care do not miss out on the childhood experiences they deserve.
