CASAs are instrumental in ensuring the system designed to protect child victims works effectively. Their advocacy helps resolve the case in a timely manner and ensures the child's best interests are considered at every decision point during the case. CASAs bring the community perspective and standard into dependency proceedings, thus contributing to the court's desire to operate openly and fairly. Utilizing trained, culturally-competent, supervised volunteers, the CASA model leverages scarce public resources and provides high-quality advocacy for the needs of children and youth.

The program also has a fund that provides for extra curricular activities, back-to-school clothing and supplies, and bikes and helmets so that children and youth in foster care do not miss out on the childhood experiences they deserve.
